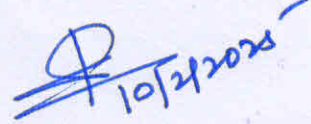

School, Sant Nagar, Burari, Delhi-84, Delhi with the following term and condition:

- i. Final outcome of the notification of MoUD, Govt. of India.
- ii. That the school shall make payment of salary and other admissible allowance to its staff teaching/non teaching as per ongoing CPC through bank/RTGS.
- iii. That the school shall comply with clause 14 of order No.F.DE/15(56)/ACT/2009/778 dated 11/02/2009 in r/o maintenance of DRF Account. School shall also ensure to follow "FN-21 Accounting by School" as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
- iv. That the school shall comply with the provisions of section 10(1) read with Rule 125 of DSEAR, 1973.
- v. That the school shall observe the relevant provisions of RTE Act, 2009 & DSEAR, 1973 and directions/Instructions issued by the Department from time to time.
- vi. That the school shall comply with the orders/guideline of DoE and judicial pronouncements w.r.t utilization/maintenance of the school funds.
- vii. That the School Authority will submit Police Verification in respect of all staff (Teaching and Non Teaching) within 03 months from the issue of letter of extension of provision recognition /up-gradation.

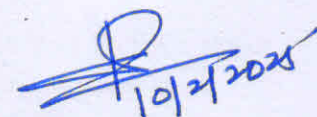
- viii. That the school shall comply with the order dated 07/11/2017 guidelines of DoE and judicial pronouncements w.r.t. the safety of the students and shall take all necessary steps to this effect.
- ix. That the school shall comply with the orders F. No. DE.15(305)/PSB/Misc./2020/Pt. File-11/5641-5647 dated 20.06.2023 regarding submission of renewed/updated certificate like Fire NOC, Water Test Report, School Health Certificate, School Building Fitness Certificate/Structure Stability Certificate to the Zonal Authorities of DoE.
- x. That the school shall appoint 2nd special educator within 02 months from the issuance of letter of approval to the District Authority.
- xi. That the School Authority will submitted Fresh Water Test Report issued by Delhi Jal Board within 01 month from the issue of letter of extension of provision recognition/up-gradation to the District North.

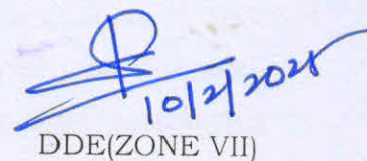
